

The Pennsylvania Supreme Court has a key role to play in determining how voter maps are drawn and ensuring that the districts are fair and competitive. Not only does the Court appoint one person to sit on the committee, but the Court makes the ultimate decision on whether the proposed districts are fair.

DEMOCRACY

The Pennsylvania Supreme Court is responsible for making sure that our environment is protected. The Court must make decisions about environmental issues such as land and water preservation, oil drilling regulations and air quality problems.

ENVIRONMENT

The Pennsylvania Supreme Court is critical in deciding on pocketbook issues that affect all of us. Whether the issue is tax subsidies for corporations, or private utility firms using government power to take a homeowner's property, the Pennsylvania Supreme Court will play a critical role in protecting economic fairness for working families.

ECONOMY

The Pennsylvania Constitution includes a provision requiring the legislature to "provide for the maintenance and support of a thorough and efficient system of public education to serve the needs of the Commonwealth." A group of teachers, parents, students, and school districts filed a lawsuit in the courts arguing that the legislature wasn't providing a fair system of funding. The Pennsylvania Supreme Court will likely decide whether the legislature must do more to provide education in Pennsylvania.

EDUCATION

ISSUES THE PENNSYLVANIA SUPREME COURT ADDRESSES

The Supreme Court oversees the operations of the entire Pennsylvania court system and works with the legislature and executive branch on judicial matters. It has several committees and boards responsible for writing and enforcing rules to ensure efficient and fair judicial review.

The Pennsylvania Supreme Court is the highest court in the state. It is comprised of seven elected justices who receive over 3,000 requests for appellate review and issue several hundred rulings each year. The justices hear cases from every corner of Pennsylvania and hold sessions in Harrisburg, Pittsburgh, and Philadelphia to hear arguments.
